## CONDITIONS FOR USE OF THE CHURCH PREMISES

1. The 'Church' refers to Hersham Baptist Church and its agents.
2. The 'Hirer' refers to the person hiring the Church hall for the purposes of this booking.
3. A deposit of £50 is payable to secure all one off bookings to hire the Church premises, unless specifically agreed in writing. The balance of the hire charge is payable on the day of hire. The deposit of £50 will be refunded following the period of hire save where:
  - (a) there has been any damage to the premises or the Church's furniture and equipment; and
  - (b) for which the Hirer is responsible.In such circumstances the Church shall be entitled to retain the whole or part of the deposit as is necessary to rectify such damage.

Payment can be made by bank transfer. Bank transfers can be made electronically to our CAF Bank Ltd account:

4. The Church retains control, possession and management of the premises and the Hirer has no right to exclude the Church from the premises.
5. The Hirer is responsible for all damage (other than fair wear and tear) to the premises or any of the Church's furnishings, equipment, fixtures and fittings which is occasioned in whatever way by the use of the premises.
6. The Church premises may only be used by the Hirer and for the purpose and during the period indicated on the application form submitted to the Church.
7. The premises are a place of Christian worship and may not be used for any purpose which (in the Church's sole discretion) conflicts with the purposes or beliefs of the Church.
8. The Hirer must ensure that no person smokes on the premises at any time.
9. After the use of the premises it must be left in a clean and tidy condition with all chairs, furniture and equipment left in the same position as at the commencement of the hiring. The Hirer must ensure that all lights are turned out, taps and switches turned off, doors and windows properly secured, and rubbish removed (and not placed in the Church's external bins). If Hirers require use of the kitchen then all crockery, cutlery and glassware must be washed and dried and returned to their correct places after use.
10. The Hirer agrees that the Church accepts no responsibility for injury or loss to person or property arising out of the use of the premises apart from such injury or loss which arises from the Church's responsibility for the general maintenance of the premises.
12. The Hirer must notify the Church of any defect in the Church's premises or equipment of which they become aware.

13. The User will comply with the provisions of the Church's Health and Safety policy and will ensure that all those using the premises are aware of the appropriate safety procedures.

14. Where premises are to be used by children, the Hirer agrees to comply with the Government's guidelines set out in the document 'Safe from Harm'.

15. The Church may terminate this agreement immediately at any time if there is a breach of these conditions by the Hirer.
